Officials Course and Accreditation Process

2022 - 2023

Surf Sports Officials education is delivered through both an online and practical 'face to face' learning environment.

Successful members who complete all learning outcomes will be eligible for accreditation as either a Core or Technical Official.

It is expected that members who commence the Officials accreditation journey acknowledge the level of commitment required to complete the learning and assessment process and will gain competency as either a Core or Technical Official within 12 months.

Prerequisites

- REGISTERED and FINANCIAL member who are a minimum of 16 years +
- MUST hold a current Working with children check – Blue Card (aged 17 ½ years +), SLSQ CYRMS and SLS Child Safe Awareness module completion.

TYPES OF OFFICIALS ACCREDITATION

Core Official

Officials working with entry level participants in a club surf sport environment (recreationally or competitively).

Core Officials need to understand the core elements of the Surf Sport environment and how this relates to officiating in junior surf sport (beach, board and swim) environments.

This course provides a basic understanding of the key events conducted for junior level competitions.

Core Officials are permitted to Officiate at any carnivals and competitions including State Championships where up to and including under 14 years age categories are conducted.

There are four duties that they can carry out: Marshall, Recording Judge, Timekeeper and Finish Judge.

Core Officials will be supervised at competitions by a competent Technical (or above) accredited Official. Permitted to Officiate at Junior level competition (U8-U14s)

Technical Official

Officials who choose to fulfil specific officiating role/s and who work with participants who are actively competing in a club / branch / state surf sport competition environment. Officiating roles may include:

- Marshall / Check-Marshall
- Starter / Check-starter
- Recorder
- Timekeeper
- Recording and Finish Judge

REGISTRATION PROCESS

Registering interested members - Interested members are required to register via their club. Once the relevant checks are undertaken to ensure membership, prerequisites and blue card status are confirmed, clubs may lodge these via this link: [NEW OFFICIAL EOI 2022-2023](#).

It is very important that the registered member email and phone details are current in Surfguard as these details will be used to communicate with the members throughout the accreditation journey.

Working with Children Check – Blue Card *No Blue Card and No Child Safety Online Modules = No Start

Clubs are required to only submit members who hold a current blue card and loaded into Surfguard.

Branches will audit candidates who nominate to commence the Officials accreditation pathway and only those who meet the prerequisite criteria and blue card status will be permitted to commence.

Members will be required to complete the following two courses:

- SLSQ Child Youth Risk Management Strategy (SLSQ CYRMS)
- SLS Child Safe Awareness

THE OFFICIALS COURSE

ONLINE LEARNING

The online modules are completed in two separate e-learning platforms. Each new Official will be required to complete and submit the relevant online modules before registering and/or attending any face to face workshop and 'on the job' assessment.

CORE OFFICIALS

The Core Officials online learning will take approximately 4 hours to complete and consists of the ASC Officiating Course and the SLS - Core Official online learning modules.

Step 1: Members Area – eLearning

 1. ASC Officiating- General Principles Course
 2. SLS - Core Official

TECHNICAL OFFICIALS

The Technical Officials online learning will take approximately 8+ hours to complete and all modules must be completed before moving to the face to face induction workshop and 'on the job' training.

Step 1: Members Area – eLearning

- Select the eLearning tab
- Select Login to eLearning
- Selected the 'Training Library' on the left of the screen
- Select SLS- Officiating and View Course
- Select SLS Technical Official
- Pay \$10.00 to enrol in the course of your choice and complete ALL 6 modules:

1. ASC Officiating General Principles Course
2. SLS - Being a Technical Official part 1
3. SLS - Being a Technical Official part 2
4. SLS Module 3a - Technical Official in Action (Marshall/Check Marshall)
5. SLS Module 3b - Technical Official in Action (Starter/Check Starter)
6. SLS Module 3c Technical Official in Action (Timekeeper, Finish Judge, Recorder)

Registered members are to upload their completion certificates for verification by the Friday prior to the face to face induction workshop via these links:

FACE TO FACE 'INDUCTION' WORKSHOP

Members who have completed the above online learning for either CORE or TECHNICAL OFFICIAL and uploaded completion certificates will then be required to attend a face-to-face 'induction' workshop before moving on to the 'on the job' training and assessment carnivals.

This workshop provides the new trainee official with the necessary information and tips for their first day on the beach.

Each new Official attending this workshop will receive a New Officials Kit containing:

- Surf Sports Officials Logbook,
- Course flip chart,
- Officials Shirt,
- Hard Copy 37th Edition Surf Sports Manual,
- 'On the Job' Assessment paperwork
- Officials Handbook.

The total cost of this pack is \$60.00 (GST inc.), which will be invoiced to the members Club after attendance at this workshop. When registering for attendance at one of the face to face induction workshops, you will also be asked to advise of your shirt size for inclusion in your New Officials Kit.

Before undertaking 'on the job' training and assessment, registration for attendance at one of the following **induction workshops** at the Branch Offices must be completed via the [Registration link:](#)

1. Wednesday 5th October 2022 at 6:30pm.
2. Wednesday 12th October 2022 at 6:30pm.
3. Wednesday 16th November 2022 at 6:30pm.

Completion Certificates must be uploaded by close of business the Friday before the above induction workshop dates. The **submission dates** are as follows:

1. Friday 30th September 2022 by COB.
2. Friday 7th October 2022 by COB.
3. Friday 11 November 2022 by COB.

Further induction workshop dates may be scheduled if required throughout the surf sports season (October to December) if required.

'ON THE JOB' ASSESSMENT

The 'on the job' training and assessment will be undertaken over a minimum of 2 allocated assessment carnivals for a Core Official, and over a minimum of 4 allocated assessment carnivals for a Technical Official; or as otherwise deemed competent by the Officials Assessor.

The Branch and State Officials Liaison Officer will communicate with all trainee officials that reach this stage about the allocated assessment carnivals.

Members have 12 months to complete this phase of accreditation.
